



MEMORANDUM OF UNDERSTANDING

Between

Chiang Mai University, Thailand

AND

Hezhou University, P. R. China

THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as the "MOU") is dated

July 18, 2019

BETWEEN

CHIANG MAI UNIVERSITY, a public research university founded under a Royal Charter granted by His Majesty King Bhumibol Adulyadej whose address is at 239 Huay Kaew Road, Muang District, Chiang Mai, 50200 **THAILAND** (hereinafter referred to as "CMU"), of the first party;

AND

HEZHOU UNIVERSITY, a state-run full-time institution of higher education established under the approval of the Ministry of Education whose address is at No. 18, Xihuan Road, Hezhou, Guangxi, 542899 **PEOPLE'S REPUBLIC OF CHINA** (hereinafter referred to as "HZU") of the other party;

CMU and HZU shall hereinafter be referred to singularly as "the Party" and collectively as "the Parties".

Both Parties, recognizing the benefits gained by both parties in academic and cultural exchange programs aimed at promoting scholarly activities and international understanding, hereby enter into the following Agreement of Cooperation in the following general areas of mutual interest. The terms of cooperation for each specific activity to be implemented under this Agreement of Cooperation shall be mutually discussed and agreed upon in writing by both parties prior to initiation of that activity.

Student Programs

1. Exchange of undergraduate and/ or graduate students
2. Semester abroad programs
3. Double degree programs
4. Global pathway programs
5. Faculty-led short-term academic and cultural exchange programs
6. Other programs of mutual interest

7. Accreditation. Both parties may send students to study courses at the other party and shall accept course credits achieved by students during their study at the other party.

Faculty and Staff Programs

1. Short-term visiting lecturer programs
2. Long-term visiting professor and research programs for faculty and graduate students
3. Customized training programs designed for teachers, faculty, staff and education leaders
4. Joint research and publication activities
5. Participation in seminars and academic meetings
6. Other programs of mutual interest

Duration and Scope of Agreement:

1. Each Institution will designate individual(s) to act as liaison officer(s) to facilitate the development, discussion, implementation, and evaluation of activities under this Agreement.
2. Both Institutions may at any time review this Agreement and the actions taken under it, and by mutual agreement make any necessary modifications.
3. The present Agreement and protocol will enter into effect upon the date of signatures by the designated and duly authorized officers of both Institutions and will last for five (5) years.
4. Either Institution may terminate the present Agreement by giving at least six (6) months' written notice, without prejudice to any of the programs underway. This agreement may be extended by mutual written agreement for a further specified period.
